Policies, Terms, and Conditions

Welcome to **JD Logic**! We are excited to help you through your law school journey.

Before you book any sessions with a JD Logic tutor, please review the following document outlining the policies, terms, and conditions that govern your relationship with JD Logic and its tutors.

1. Acceptance of Terms

- By accessing or using our tutoring services, you agree to comply with and be bound by these terms and conditions. If you do not agree with any part of these terms, you may not access or use our services. These terms are not negotiable and cannot be modified by students or tutors without written consent from JD Logic.
- This document represents JD Logic's complete written record of policies, terms, and conditions and supersedes any other published or otherwise represented policies, terms, or conditions.

2. Services Provided

- JD Logic and its tutors provide professional law school tutoring services including assisting students with their doctrinal course work and writing & research courses.
- Our tutoring services are designed to supplement your legal education and enhance your understanding of law school subjects. Tutors are not responsible for a student's ultimate success or failure in a specific subject or law school as a whole.
- Tutors are experienced professionals with expertise in various legal subjects. However, they are not substitutes for legal advice or professional legal services.
- Services are provided by individual tutors who make tutoring and scheduling arrangements with students directly. Scheduling of tutoring sessions is subject to tutor availability and must be arranged in advance.
- Sessions are conducted exclusively online. Communication between tutors and students is conducted via email, video conferencing (Zoom), phone call, or messaging through the JD Logic website. Tutors will not engage in text messaging with students.

3. Rates, Fees, and Payment

- Fees for tutoring services are specified at the time of booking and are non-negotiable.
- Individual tutoring sessions are billed at a rate of \$68/hour.
 - Preparation Time: Students are not billed for a tutor's reasonable preparation time. Reasonable preparation time includes up to 1 hour of preparation per 1 hour of meeting time.
 - If a tutor believes preparation will require more than the allotted 1-hour preparation time, the tutor must discuss reasonable billing with the student before continuing preparation.
- Editing time: For writing courses and projects, students are billed for reasonable editing time.
 - Editing time is billed at a rate of \$68/hour.
 - Editing time refers to time a tutor spends making edits, comments, and suggestions on your document.
 - Your tutor can give you an estimate of how long they expect the editing process to take.
 - To avoid overages, a tutor may limit their efforts to the estimate. Tutor will contact students before incurring time overages unless the student has previously consented to overages.
- Legal Research: Tutors will not conduct research for students.
 - Generally, tutors will not review the cases cited in a student's paper. Tutors rely on students to provide accurate and honest representations of cases.
 - Upon request, and upon provision of copies of cases from the student, a tutor may agree to read and review cases.
 - If a student needs help with research, a tutor may engage in one-on-one sessions reviewing research methods with the student including sharing a screen to conduct research.
 - Any research assistance (as allowed above) is billed at a rate of \$68/hour.
 - Never ask your tutor to conduct legal research for you. This violates JD Logic's internal code of conduct and likely violates your school's academic integrity policy.
- Minimum Booking Time: all sessions must be booked for a minimum of one (1) hour (60 minutes).
 - Sessions may be scheduled in excess of 60 minutes and are billable in 15-minute increments at a rate of \$17 per increment.
- Group rates are available at the following rates:
 - \$90/hour for 2 Students (\$45/per student/hour).
 - \$120/hour for 3 Students (\$40/per student/hour).
 - For larger groups, please contact JD Logic for rate information.
 - Reasonable preparation time for group session is 1-hour per every hour of time booked.

- Payment is due in full prior to the commencement of each tutoring session.
 - Tutors will not render services until payment has been fully satisfied.
 - Failure to make payment will result in preclusion from further bookings.
 - JD Logic may pursue any and all means for collecting unpaid balances.
 - Deliberate or willful failure to make payment may result in JD Logic or its tutors reporting behavior unbecoming of the legal profession to a student's law school or state bar associations.
- JD Logic accepts payment via Credit Card, Venmo, or Zelle. All transactions are secure and encrypted.
- Payment may be collected by JD Logic or by tutors.
- Exceeding scheduled session: when students have reached the end of their scheduled session, the tutor may end the session.
 - If the tutor and student mutually agree to extend the session, students will be billed in 15-minute increments at a rate of \$17 per increment.

4. Cancellation and Rescheduling

- If you need to cancel or reschedule a tutoring session, you must provide at least 24 hours' notice to avoid a cancellation fee.
- A no-show or failure to provide sufficient notice (24 hours) may result in forfeiture of fees for the canceled session or imposition of a cancellation fee.
 - Failure to appear within 10 minutes of the schedule start time will be considered a no-show. After 10 minutes beyond the scheduled start time, the tutor may treat the session as a no-show and bill the student according to the policies enumerated here.
- The cancellation fee is equal to 50% of the originally booked appointment's rate.
 - Example: An appointment for 1 hour that is missed or cancelled less than 24 hours in advance; student will be charged \$34 cancellation fee (50% of \$68).

5. Intellectual Property

- All materials provided during tutoring sessions, including but not limited to notes, handouts, and practice questions, are the intellectual property of JD Logic.
- You may use these materials for personal study purposes only and may not reproduce, distribute, or publish them without prior written consent.

6. Code of Conduct

- You are expected to conduct yourself in a professional and respectful manner during tutoring sessions.
- Any form of harassment, discrimination, or inappropriate behavior will not be tolerated and may result in immediate termination of services.

7. Academic Integrity

- All law schools have policies about what assistance students are allowed to accept. Individual professors or classes may enact additional policies on academic integrity.
- As a law student, you have entered a self-governing community of legal professionals who are deeply concerned with honesty and integrity.
- JD Logic and its tutors will never intentionally run afoul of a law school's academic integrity policies.
- JD Logic is not a paper-writing or assessment-taking service and will not provide such services.
- It is a student's responsibility to understand their school's academic integrity policies and ensure that any service they accept from JD Logic or its tutors is in conformity with such policies.
- A student's misrepresentation of his/her school's academic integrity policies are grounds for immediate termination of services. Additionally, any deliberate or willful misrepresentation of any academic integrity policy on the part of a student is grounds for JD Logic or its tutors reporting conduct unbecoming of a legal professional to the student's law school or state bar association.
- In no event shall JD Logic, its tutors, or affiliates be liable for any student violation of academic integrity policies.
